The Authorized Officer/Secured Creditor shall not be responsible in any way for any third party claims/rights/dues. - 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.
- 7) The interested bidders who may have submitted their EMD not below the 10% of reserve price through online mode before 5.00 P.M. on 03.06.2025 shall be eligible for participating in the e-auction.
