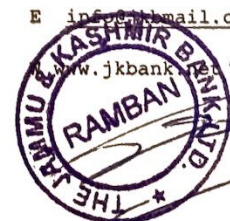

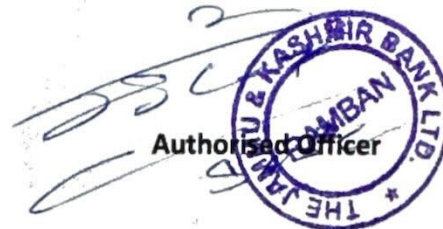


For any kind of dispute, bidders are required to contact the concerned authorised officer of the concerned bank branch only.
