B. General instructions/Terms and Conditions.

- i. Bidders have to apply for the bids on <https://jkbank.abcprocure.com/EPROC/> after registration.

- iii. Firms/ Persons interested in the purchase of the above-mentioned vehicles may inspect them on any working day from 15.12.2025 to 18.12.2025 between 10:30 AM to 04:00 PM at the CHQ M. A Road Srinagar for Vehicle bearing registration no. JK01M-1100 and for remaining vehicles, same may be inspected on 19.12.2025 between 01:00 PM to 04:00 PM at Pampore adjacent to JKEDI building (*Old Joinery Mills*).
- iv. Vehicles will not be sold below reserve price.
- iv. The bidders are advised to quote individually for the make and models of vehicles listed above in the online auction only. No offline bidding will be permitted. Interested persons should participate in the auction conducted through the Tendering Portal of the Bank <https://jkbank.abcprocure.com/EPROC/>.
- v. In case the date of opening of tenders is declared as a holiday or any of the tender opening committee members is not present in the office, the tenders will be opened on the next convenient working day at the same time.
- vi. It is an item-wise auction and Separate Highest amount H1 will be identified separately for each item through auction (Each vehicle). Hence the amount shall be quoted separately for each vehicle by each individual/bidder.
- v. Bank reserves the right to cancel or reject any or all offers without assigning any reason.
- vi. Bank also reserves the right to call for any Documents during the technical Evaluation stage.
- vii. No Bid will be accepted after the last date & time specified for bid submission under any circumstances. Bank will not be responsible for any delay, in submission of the bids on behalf of bidders.
- viii. Tender fee and bid security money (EMD) can be submitted online in the account mentioned in the auction notice and proof of that may be uploaded on e- tendering portal. Bids without Tender fee and EMD will be summarily rejected. However (EMD) shall not be applied to MSMEs Startups as per DIPP.
- ix. The interested bidder shall have to Bid for all vehicles and in no case bidding for part items shall be allowed. Any bid submitted for partial items shall be rejected out rightly.
- x. Successful bidder shall be decided on the basis of highest aggregate bid amount quoted in forward Auction process/financial bid. Furthermore, in no case bid offer less than the base price/reserve price in aggregate fixed for the auction sale shall be accepted by the Bank and in that scenario the Bank may opt for re-tendering process.

C. Other Terms and Conditions

- i. Each page of tender document should be signed by the bidder(s) in token of acceptance of terms and conditions of tender. Bid may be submitted with a forwarding letter on letter head of the Bidder. The bidder shall quote the rates clearly both in figures and words and should be prefixed by the word Rupees and avoid overwriting.
- ii. Incomplete bids/conditional bids/ bids having deviations from the NIQ shall be liable for rejection.
- iii. Bid Form is attached with this Tender Notice at Annexure I.
- iv. Bids once submitted shall not be allowed to be withdrawn. Any default after acceptance of bid shall be deemed to be non-compliance to the terms.

- v. The EMD of unsuccessful bidders shall be returned on submission of Bank details & permanent account number without any interest.
- vii. The item, once disposed to the successful bidder shall not be taken back by the Bank.
- viii. The successful bidder shall be required to lift all the items at their own cost from the disposal site to his/her premises within 02 Weeks after the payment of the quoted amount in the presence and supervision of Bank's Team. No extensions of time will be given under any circumstances. However extension of time may be granted provided convincing and satisfactory reasons for such delay is given in writing by the successful bidder. Delay beyond the stipulated time may entail cancellation of the award/order and EMD shall stand forfeited.
- ix. Bank will not be held responsible for any loss or damages or theft of the material after the bid is finalized and sale letter issued to the buyer, and no claim for compensation thereof, will be entertained.
- x. The successful bidder will be allowed a maximum period of 05 working days after receipt of the confirmation letter to remit quoted amount. The lifting of item will not be allowed before the submission of quoted amount.
- xi. Final Decision to accept /reject the bids shall be taken by the Bank on the basis of eligibility criteria and highest financial quote.
- xii. The bids shall be submitted in the prescribed bid format given (Annexure-II) of this document.
- xiii. No Bid may be modified subsequent to the deadline for submission.
- xiv. The bidder shall take full responsibility in case of any damage, loss or injury to any person building of any part thereof, and shall repair/ and make good the loss at his own cost.
- xv. Conditional bids/deviations from NIT shall be liable for rejection.

xvi. Mere quoting highest rate shall not make the bidder successful. The rates finalized after forward auction to be carried out on a subsequent date, shall be final and successful bidder will be declared accordingly as per rates quoted.

xvii. The successful bidder has to make full payment through demand draft in favour of Deputy General Manager CHQ Jammu & Kashmir Bank or deposit directly in the account (to be conveyed by this department) within 05 working days after the receipt of the confirmation/sale letter, failing which the offer may be cancelled and EMD shall stand forfeited. xx. EMD of the successful bidder(s) will be released only after realization of sale proceeds amount and transfer of ownership of vehicle. EMD of the bidders who fail to honor the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this department. EMD amount will not be adjusted in the sale amount accepted by Bank. EMD of unsuccessful bidder(s) shall be released only after successful completion of the sale process.

xxi. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters identity Card/ Aadhar Card/ Passport in case of individual and Registration Certificate in case of firms etc.

xxii. The sold vehicle will be removed by the successful bidder(s) by depositing the money at their own expenses. No assistance/ transportation will be provided by the Bank. Permission to take out the disposed vehicles from Bank's premises will be allowed only on working days.

xxiii. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.

xxiv. Sale letter will be executed in favor of the Successful Bidder on depositing the entire sale consideration. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously in the
