Whereas, the Authorized Officer of The Jammu & Kashmir Bank Ltd in exercise of powers conferred under SARFAESI Act, 2002 and Security Interest (Enforcement) Rules, 2002, issued a Demand Notice under section 13(2) of the Act on **16.12.2021** calling upon Mr. Aijaz Ahmad Bhat S/O Ab Razak Bhat R/O Bonabazar Shopian and its **guarantors/ Mortgageors**, to pay their outstanding dues in the loan account/s aggregating to **Rs.82,02,616.45 (Rupees Eighty Two Lac Two Thousand Six Hundred Sixteen and Forty Five Paisa)** together with future interest & other costs and charges **within a period of 60 days**.

Whereas, upon failure of the borrower to repay his dues, the Authorized Officer took over the possession of the mortgaged properties mentioned hereinafter under section 13 (4) of the SARFAESI Act 2002 on **05.03.2024** and issued possession notices dated **05.03.2024** which were published in daily newspapers.

- 1) The E-Auction is being held on "As is where is", "As is what is", "Whatever there is" and "No complaint" basis. To the best of knowledge and information of the Authorized officer, there are no encumbrances on the properties, except specifically disclosed herein. However, the intending bidders should make their own independent enquiries regarding the encumbrances, title of property/ies put on auction and claims/rights/dues affecting the property, prior to submitting their bid. The Authorized Officer/Secured Creditor shall not be responsible in any way for any third party claims/rights/dues. The bidders shall satisfy themselves as to the description, condition or accuracy of the details regarding the property/ies given hereinabove.
- 2) It shall be the responsibility of the bidders to inspect and satisfy themselves about the asset and specification before submitting the bid.
