### 1. Introduction

The Ministry of Rural Development (Skills Division) Govt. of India has implemented the schemes of Rural Self Employment Training Institutes (RSETIs) Pan India to impart the training and skill development programs to the rural youth. The main objective of these institutes is to conduct entrepreneurship development training programs so that they can earn their livelihood.

In the UT of Jammu & Kashmir, J&K Bank is sponsoring 12 RSETIs viz JKBRSETIs functioning in 12 districts

managed by the J&K Bank Rural Self Employment Training Institutes Society (J&K Bank RSETI) established in compliance to the guidelines of Ministry of Rural Development GOI and registered under Societies Registration Act 1860.

## 2. Purpose of RFP

JKBRSETIs impart trainings to unemployed rural youth under various courses one of them being Tailoring which is currently in vogue and Sewing Machines shall come in handy to instill practical skills in trainees. This Request for Proposal (RFP) document has been prepared solely to enable Jammu and Kashmir Bank Rural Self Employment Training Institutes Society to procure 120 Sewing Machines with Base and Handle for 12 Rural Self Employment Training Institutes (10 each) namely as mentioned below:

## 3. Scope of Work

The selected vendor shall be providing 120 sewing machines along with service (repair and spares) under warranty period of at least one year.

## 4. Selection of Vendor

L1 Vendor (Lowest Quote) shall be selected and notified accordingly to whom procurement order shall be placed, the submission of quote shall mean that vendor accepts to deliver and install the machines at location in the districts mentioned in the table at point 2 in brand new condition and damage risks caused during transportation shall be borne by the supplier/vendor.

The Quote price shall include 120 sewing machines cost, delivery at 12 districts (10 each), installation charges and any other possible cost including all taxes.

## 5. Eligibility Criteria for submitting the quote;

Vendors meeting the following criteria shall be eligible to submit their quotes along with the documents.

- i) Valid GST Registration Certificate
- ii) Registered vendor/distributor/C&F agent (Carrying and Forwarding)/retailer of the Company.
- iii) Registered office in the UT of J&K.
- iv) At least three years in the business with the successful execution of supplying at least 5 orders of

such type.

## 6. Procedure for Selection of Supplying Firms.

The quotes submitted during the RFP period shall only be accepted, which shall be analyzed and subsequently the quote with lowest amount shall be shortlisted.

## 7. RFP Submission.

### 7.1 Only One Submission

Only one submission by each vendor shall be permitted. The vendor will submit the response only in the online mode, a submission in the different manner, including a submission through fax or email, shall not be accepted by the JKBRSETI Society and will be summarily rejected.

### 7.3 Deadline for submission of RFP

- Quotes must be received online and by the date and time mentioned in the “General Details about the RFP”.
- Any quote received after the deadline for submission of bids prescribed, for any reason whatsoever, will be rejected.

### 7.4 Payment Terms

The Jammu and Kashmir Bank Rural Self Employment Training Institutes Society would place order of procurement and pay amount as per the shortlisted quote which shall include item costs, installation cost, transportation/delivery cost or any other cost to be incurred.



Bank shall deduct TDS as per the rates prescribed by the govt. and a retention money of 10% shall be withheld for one year which shall be paid consequently after retention period of one year on the basis of satisfactory performance of products and services provided.

### 7.5 Earnest Money Deposit

EMD to the tune of 5% of bid amount (Rs.30,000/-Thirty Thousand Only)shall have to be deposited before submission of the bid which shall be refunded to unsuccessful bidders and after successful fulfillment of the order to the one with whom order will be placed, however Micro and Small Enterprises (MSEs) (as per Updated MSME Classification 2025) holding Udyam Registration shall be exempted from EMD clause.

### 7.7 E-Reverse Auction

The shortlisted bidders shall have to participate in the reverse auction which shall be conducted online through e-tendering portal <https://jkbank.abcprocure.com>, date of which shall be notified separately

## 8. OTHER TERMS:

8.1 The Jammu and Kashmir Bank Rural Self Employment Training Institutes Society reserves the right to accept or reject any quote without assigning any reason thereof. The decision of I&K Bank RSETIs in this regard shall be final and binding. In case of doubt, decisions of the Technical Evaluation/ Selection Committee shall be final. It may be noted that The Jammu and Kashmir Bank Rural Self Employment Training Institutes Society shall not pay any cost of any kind for providing service during the warranty period.

8.2 The Bidder shall, by responding to the J&K Bank RSETI with a bid/proposal, be deemed to have accepted the terms of this document and the disclaimer in totality without any condition whatsoever and accepts the selection and evaluation process mentioned in this RFP document. The bidder ceases to have any option to object against any of these processes at any stage subsequent to



submission of its responses to this RFP.

### **8.2 Subcontracting of Assignment:**

Either party shall not assign, in whole or in part, the benefits or obligations of contract to any other person without the prior written consent of the other party, such consent not be unreasonably withheld.

### **8.3 Termination:**

J&K Bank RSETIs Society shall have the option to terminate/cancel this RFP at any stage without any prior notice and without assigning any reason whatsoever.

### **8.5 Confidentiality**

The shortlisted vendor shall maintain complete confidentiality of the deal and shall not share any information with anyone.

### **8.6 Applicable law and jurisdiction of court.**

The contract with the selected bidder shall be governed in accordance with the laws of UT of J&K read with laws of India so far as they are applicable to the UT of J&K for the time being enforced and will be subject to the exclusive jurisdiction of courts at Srinagar.

### **8.7. No liability**

All employees engaged by the Service Provider / Vendor shall be in sole employment of the Service Provider / Vendor and the Service Provider / Vendor shall be solely responsible for their salaries, wages, statutory payments etc. That under no circumstances shall J&K Bank Rural Self Employment Training Institutes Society be liable for any payment or claim or compensation (including but not limited to compensation on account of injury/death/termination) of any nature to the employees and personnel of the Service Provider / Groups.

Under no circumstances J&K Bank Rural Self Employment Training Institutes Society Ltd shall be liable to the Service Provider / Groups for direct, indirect, incidental, consequential, special or exemplary damages arising from termination of this Agreement.

This RFP is not an offer but an invitation for quotes for selling sewing machines. No contractual obligation on behalf of the Bank whatsoever shall arise from this RFP unless and until formal engagement/ appointment is conveyed in writing by duly authorized officers of the Bank.

As per Central Vigilance Commission (CVC) directives, it is required that Bidders / Suppliers / Contractors observe the highest standard of ethics during the procurement and execution of such

contracts.

### 8.8. Breakdown under warranty period and penalty

Technician/s of shortlisted vendor shall reach and rectify any operational issues with machines when informed (through any medium (Call, Email, WhatsApp etc) within 72 hours during the warranty period including the replacement of spares without any cost. In case of any further delay society shall have the right to deduct penalty amount from retention money in proportion to the work loss suffered.

### 8.9 Bid submission period and its extension

Bidding shall be open for 21 days initially, in case bids received are less than 3 JKBRSETI Nodal Office CHQ shall have the right to extend the period by 14 days in the first extension and further to a maximum of 7 days in the second extension. However, this cannot be claimed as a matter of right.

### 8.10. Disclaimer:

### 8.12 Corrupt and Fraudulent Practice

- i. The bidders shall observe the highest standard of ethics during the procurement and execution of such contract and shall not indulge in any corrupt and fraudulent practice.
- ii. 'Corrupt practice' means the offering, giving, receiving or soliciting of anything of value to influence the action of an official in the procurement process or in contract execution.
- iii. 'Fraudulent practice' means a misrepresentation of facts to influence a procurement process or the execution of contract to the detriment of the bank and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive J&K Bank RSETI of the benefits of free and open competition.
