INSTRUCTIONS TO BIDDERS

Bids are invited from **E-Waste certified vendors** who comply with general terms and conditions and scope of work as per following for auction/sale of old ATMs(Automatic Teller Machines) lying at Zonal Office Jammu and various **Branches** within jurisdiction of Zonal Office Jammu on “as-is -where-is” basis.

1. The bid document can be downloaded from our website URL: www.jkb.bank.in
2. The bid shall be submitted in a two-bid system comprising a Technical Bid and a Financial Bid, each enclosed in separate sealed envelopes. Both sealed envelopes shall be placed inside a larger sealed envelope superscribed with the tender details.
3. The Financial Bids of only those bidders who qualify the Technical Bids evaluation shall be opened and considered for further evaluation. The Financial Bids of technically disqualified bidders shall be remain unopened.
4. No Bid will be accepted after the last date & time specified for bid submission under any circumstances. Bank will not be responsible for any delay, in submission of the bids on behalf of bidders.
5. Tender fee and bid security money (EMD) can be submitted online in the account mentioned in the auction notice. Bids without Tender fee and EMD will be summarily rejected.
6. The interested bidder shall have to Bid for all items and in no case bidding for part items shall be allowed. Any bid submitted for partial items shall be rejected out rightly.
7. Successful bidder shall be decided on the basis of highest aggregate bid (H1). If necessary, Bank reserves the right to form an appropriate negotiation committee to have negotiation with the H1 bidder. In case the H1 bidder is not able to accept the sale letter within 7 days, the same will be offered to next higher bidder (H2) at rate given by H1. Furthermore, in no case bid offer less than the base price/reserve price in aggregate fixed for the auction sale shall be accepted by the Bank and in that scenario the Bank may opt for re-tendering process.
8. The successful bidder shall submit an undertaking/certificate that e-waste items will stored /processed/disposed off as per Rule(s) of E-Waste (Management and Handlings), rule 2016 as applicable) notified by the Ministry of Environment and Forests vide Notification dated 23 march-2016 or any other notification subsequent to it.



General Terms and Conditions

1. The details of the items along with their base price/reserve price etc. to be auctioned-off are listed at Annexure-III.
2. Each page of tender document should be signed by the bidder(s) in token of acceptance of terms and conditions of tender. Bid may be submitted with a forwarding letter on letter head of the Bidder. The bidder shall quote the rates clearly both in figures and words and should be prefixed by the word Rupees and avoid overwriting.
3. Incomplete bids/conditional bids/ bids having deviations from the NIQ shall be liable for rejection.
4. Bid Form is attached with this Tender Notice at Annexure-II
5. Details of the item to be auctioned and reserve price are listed as per Annexure -III.
6. Tender/Bid without Tender Fee, EMD and E waste certification shall be summarily rejected.
7. Bids once submitted shall not be allowed to be withdrawn. Any default after acceptance of bid shall be deemed to be non-compliance to the terms.
8. The bidders may inspect the item on predetermined dates and satisfy themselves about the item they are bidding for.
9. The EMD of unsuccessful bidders shall be returned on submission of bank details & permanent account number without any interest.
10. The item, once disposed to the successful bidder shall not be taken back by the Bank.
11. The successful bidder shall be required to lift all the items at their own cost from the disposal site to his/her premises within 01 Weeks after the payment of the quoted amount in the presence and supervision of Bank's Team. No extensions of time will be given under any circumstances. However extension of time may be granted provided convincing and satisfactory reasons for such delay is given in writing by the successful bidder. Delay beyond the stipulated time may entail



cancellation of the award/order and the entire quoted amount paid by the successful bidder to the Bank till then shall stand forfeited besides the Bank shall be free to offer the items to the next higher bidder or to again put the items to auction in its absolute discretion.

12. Bank will not be held responsible for any loss or damages or theft of the material after the bid is finalized and sale letter issued to the buyer, and no claim for compensation thereof, will be entertained.
13. The successful bidder will be allowed a maximum period of 07 working days after receipt of the confirmation letter to remit quoted amount. The lifting of item will not be allowed before the submission of quoted amount.
14. Final Decision to accept /reject the bids shall be taken by the bank on the basis of eligibility criteria and highest financial quote.
15. The bids shall be submitted in the prescribed bid format given (Annexure-II) of this document
16. No Bid may be modified subsequent to the deadline for submission.
17. The bidder shall take full responsibility in case of any damage, loss or injury to any person, building or any part thereof, and shall repair/ and make good the loss at his own cost.
18. Conditional bids/deviations from NIT shall be liable for rejection.
19. The bidder will observe all necessary precautions at his own cost to safeguard his workers during execution of work. In case of any accident/mis-happening, contractor will be responsible for the safety of his workers and Bank will not take any responsibility in this regard.
20. All bidders must enclose the copy of PAN / GST Registration along with tender document. (Undertaking must be submitted if not applicable duly specifying reason thereof).
21. Mere quoting highest rate shall not make the bidder successful. The rates finalized after forward auction to be carried out on a subsequent date, shall be final and successful bidder will be declared accordingly as per rates quoted.
22. The successful bidder has to make full payment through account transfer in Sundry account of Zonal office Jammu within 7 days (calendar days) of the issuance of acceptance letter/sale order by the Bank, failing which the offer may be cancelled and EMD shall stand forfeited.
23. The Bank reserves the right to withdraw this notice at any time without assigning any reason thereof.

Arbitration and jurisdiction

In case of any dispute regarding any of the terms of this tender and the matters related thereto, the decision of the Incharge General & Estates Department stationed at Zonal Office Jammu of the J&K Bank shall be final and binding on all the parties. All legal Disputes, if any, will be subject to the Jurisdiction of Courts at Jammu.

“If the dispute cannot be settled amicably within fourteen (14) days from the date on which either Party has served written notice on the other of the dispute then any party can submit the dispute for arbitration under Arbitration and Conciliation Act, 1996. The parties hereby agree that the DGM Zonal Office Jammu shall be the sole arbitrator whose decision shall be final and binding upon the parties.”

CRITERIA TO AWARD

1. The selection of bidder will be decided on the basis of highest aggregate auction price quoted in the submitted bid/forward auction.
2. In case the items to be disposed-off cannot be taken up by the highest acceptable bidder within 7 days from the date of payment of the entire quoted amount to the Bank, the offer may be given to the next lower bidder(s) at the price offered by the highest acceptable bidder

3. Payment Terms

The successful bidder has to make full payment through account transfer in Sundry account of Zonal office jammu within 7 days (calendar days) of the issuance of acceptance letter/sale order by the Bank, failing which the offer may be cancelled and EMD shall stand forfeited.

4. Cancellation by Default

J&K Bank may without prejudice to any other remedy for breach of terms and conditions including forfeiture of EMD and all other amount including the quoted amount paid by the successful bidder till then and terminate the sale order in whole or in part after sending a notice to the successful bidder in this regard, if:

- (a) The successful bidder fails to take up the receivables/goods in accordance with the terms and conditions within the time period (s) specified in the Tender Document.
- (b) The selected bidder fails to perform any other obligations under the terms and conditions.

5 Force Majeure

If, at any time, during the continuance of the agreement, the performance in whole or in any part by either party of obligation under the agreement shall be prevented or delayed by reasons of any war, hostile acts of the enemy, civil commotion, subrogate, fire, floods, earthquakes, explosions, epidemics, strikes and quarantine restrictions by acts of God, (herein after referred to as eventualities) then provided notice of the happening of any such eventualities is given by either party to the other within two days from the date of occurrence thereon, neither party shall, by reason of such eventualities be entitled to terminate this contract agreement nor shall either party have any claim of damages against the other in respect of such non-performance or delay in performance. Performance of the contract agreement shall, however be resumed as soon as practicable after such eventuality has come to an end.

2. We agree that e-waste will be stored in a secured, demarcated area to prevent damage to the environment and prevent breakage.
3. We undertake that the e-waste will not be stored beyond a period of **180 days** without taking special permission from the State Pollution Control Board (SPCB).
4. We certify that all generated e-waste will be handed over only to registered/authorized dismantlers, recyclers, or collection centers, ensuring environmentally sound management.
5. We will maintain records of e-waste generated, stored, and handed over to the authorized agency in the required format (Form 2) and make them available for inspection by SPCB/CPCB authorities.
6. We will ensure that the transportation of e-waste is carried out securely and degaussing of any storage media to be done as per norms, accompanied by appropriate documentation (manifest as per Form 6).
